All services, offered by D.B.S.G Stylos, are performed by the board or committees supervised by the board. To provide these additional services, the processing of additional personal data is required. The additional services are divided into five categories:

- Travel
- Career
- Activities
- Education
- Publications

To use the services mentioned above, permission for the processing of a number of specific personal data is required. D.B.S.G Stylos may only request, process or share additional personal data (indicated by subject), provided the user has met two conditions.

- The (external) member agreed with the *General Privacy Policy*.
- The (external) member has registered for a service that has indicated that it is part of one of the five service categories.
